SUO MOTU DECLARATION UNDER SECTION 4 OF RTI ACT 2005

Introduction and Background Information:

Jawaharlal Nehru Port, also known as Nhava Sheva port, is the largest container port in India. East of Mumbai, in the state of Maharashtra, JNPT handles the majority of India's containerized trade, and is the focal point of long-haul calls to and from the emerging market economy. DP World's "futuristic" Nhava Sheva (India) Gateway Terminal (NSIGT) achieved 6,017 TEUs of combined exports and imports in the course of about 33 hours when it serviced MSC Perle, recording a gross berth productivity of 141.14 moves per hour. JNP consist of a full-fledged Custom House, 30 Container Freight Stations and connectivity to 52 Inland Container Depots across the country.

- **Demographic Profile:** Situated south east of Mumbai, Area 200sq kilometers, there are 5 terminals at the **Nhava Sheva Port** and 4 of them are privately managed. Operational berths are BMCT, GTI, NSIGT, NSICT (DP World).

Particulars of the Organisation, functions & duties (Section 4(1) (b) (i)):

The Port Health Organisation, JNPT Navi Mumbai is a Subordinate Office of the Government of India, Ministry of Health & Family Welfare, Directorate General of Health Services, Department of Health, and New Delhi.

- c. Inspection and Issuance of Ship Sanitation Certificates.
- d. Inspection of provision and Issuance of Provision certificate.
- e. Inspection and Issuance of Medicine Chest certificate.
- f. Clearance of Dead body.

B) Sanitary Inspection and Monitoring and Supervision of Sanitary, Vector & Rodent control measures at JNPT Port, Docks and its surrounding area of 400 sq. Mtrs. And advise as per findings to improve sanitary conditions of the premises.

C) Monitoring and Supervision of sanitation control of cargo handling areas and yards.

D) Licensing of catering establishments: Total 8 Canteen are there in JNPT Port Premises. FSO of our department carry out regular inspection of canteen.

F) Other activities: -Support in case of Local Events.

G) During Public Health Emergency of International Concern (PHEIC):-

- a) Effective contingency arrangements to deal with unexpected PHEIC.
- b) Training of other stakeholders regarding PHEIC /any health-related event about the event, Prevention, control, use of PPE etc

Powers: - Being Subordinate staff, No independent powers.

Duties:- All ministerial and non-ministerial staff to perform duties allocated by Head of Office for works related to establishment, accounts, stores etc. including assisting officers in substantive functions.

3. Procedure followed in the decision-making process, including channels of Supervision and accountability (Section 4(1) (b) (iii)):

This organization is a Subordinate Office under the Govt. of India, Min. of Health and Family Welfare, the Directorate General of Health Services, PH (IH) Section and established for the implementation of policies of the Government of India. Dealing Assistants to DDO /Head of Office. No intermediate supervision is available.

The Port Health Officer is accountable for decisions taken in the matter related to administrative as well as substantive functions attended by him and Medical Officer/Deputy Port Health Officer is accountable in the matter related to substantive functions allocated and executed by him/her at this subordinate office level.
